THE INFORMATION WE COLLECT:

IF YOU CHOOSE TO GIVE TO UNITED WAY, YOU COMPLETE A PLEDGE FORM THAT ASKS YOU TO PROVIDE US WITH YOUR NAME, ADDRESS, E-MAIL ADDRESS, AND PLEDGE INFORMATION.

UNITED WAY WILL NOT RENT, TRADE, SELL, OR SHARE ANY INFORMATION ABOUT ITS DONORS.

ACCESS TO THE INFORMATION:

UNITED WAY EMPLOYEES WHO MAY ACCESS YOUR INFORMATION IN ORDER TO PERFORM PLEDGE PROCESSING AND ADMINISTRATIVE FUNCTIONS ARE PROHIBITED FROM DISCLOSING YOUR INFORMATION TO THIRD PARTIES.

ORGANIZATIONS THAT PROVIDE OPERATIONAL OR OTHER SUPPORT SERVICES TO US MUST ALSO AGREE TO SAFEGUARD YOUR INFORMATION IN STRICT COMPLIANCE WITH OUR PRIVACY POLICY.

WHY DO WE COLLECT THIS INFORMATION:

YOUR RELATIONSHIP WITH UNITED WAY IS VOLUNTARY AND CONFIDENTIAL. WE USE YOUR INFORMATION TO SEND YOU ACKNOWLEDGEMENTS OF YOUR GIFT AND INFORMATION WE THINK YOU MAY FIND OF INTEREST ABOUT UNITED WAY. IF YOU DO NOT WISH TO RECEIVE SUCH COMMUNICATIONS, YOU MAY LET US KNOW AT ANY TIME BY CONTACTING UNITED WAY. IN ADDITION, EVERY E-MAIL MESSAGE YOU RECEIVE FROM UNITED WAY WILL INCLUDE INSTRUCTIONS ON HOW TO UNSUBSCRIBE.
